EKF RULES & REGULATIONS FOR BREED CLUBS

Preamble: definition

The breed club (BC) is an organization that is formed by a group of certain breed fanciers who are aiming of serving the breed in the country, and the Egyptian Kennel Federation (EKF) has only one BC member representing the breed in the country.

The breed club is concerned for developing and improving all about the breed cynology, especially popularization, affording advises, breeding and training dogs in accordance with the cynological ethics principles.

Organize, support and impact on the professional training of experts at cynological aspects.

- 1- The BC has to follow the EKF Statutes and EKF rules & regulations.
- 2- The BC is only allowed to work inside the territory of Egypt.
- 3- The BC has to submit to the EKF:
 - a- Statutes.
 - b- Board members.
 - c- Full name in English.
 - d- English name abbreviation.
 - e- Logo.

The main and basic objectives of the breed club

- The main purpose & aim of the BC is conducting the kennels that are registering in the EKF, people who are owning & breeding the breed through their registered dogs in EKF.
- Improving & enhancing the breed in the country collecting information about the breed from inside & outside the country & sharing this information.
- Collecting information on the state of the breed in Egypt and abroad, exchanging information.
- Following the EKF breeding rules and strategy.
- Participating in all activities of the national club.
- Organizing national & regional dog shows, sport activities, seminars for their breed and any other activities which are improving the breed.

- Establishing relations with foreign breed clubs.
- Joining the international breed organizations after the EKF approval.
- Hosting the different international breed shows after the EKF approval.
- Implementing the necessary rules for the breed (special provision & requirements for breeding) after the EKF approval.
- Organizing national and regional exhibitions (for the breed) specialized testing, breeding qualifications, seminars for breeders and judges and other canine events aimed at development and promotion of the breed.
- The breed club is responsible for all ways relate to their breed as promoting, breeding, training and presenting all means of promoting and developing the breed.
- Publication of the results of their breed activities and breeding work with breed.
- Drafting documents aimed at improving the breed. These include: the development of regulations and requirements to a select breeding, implementation of educational and methodical work with breeders and dog experts, the organization of breeding shows and biometric surveys.
- Doing the domestic breed statistics based on the qualities afforded and drawing the plan of enhancing the breed, then acknowledging the EKF.
- Educating their own cynologists & breeding advisors.
- Educating their nominated judges' candidates to the EKF.

Members

- Accepting members & their criteria is up to the BC's authority.
- Only membership requests which have been rejected by the national club EKF cannot be accepted by the BC.
- The BC accepts to execute the EKF disciplinary committee of suspending any member of the BC.

Fund

- The BC is collecting money through donation, membership subscription, sponsorship, services fees and activities subscription.
- Foreign fund is not permitted due to the Egyptian government rules.

Certificates

- The BC is entitled to issue its own different CH certificates.
- The BC is not allowed to issue its own either puppy card or pedigree.

Foreign agreements or memberships

If the BC has an intention of establishing a cooperation with a foreign same breed international organization, all the terms of cooperation, membership, agreement, documents, contract, and contacts must be submitted to the EKF and approval must be granted.

Activities

- The BC is free to draw its own activity plans.
- The BC activities annual plan must be submitted to the EKF before the year starts regarding approval.
- Dog show judges & working trails judges list must be submitted for the EKF before the show or trail date with at least six months.

Dog shows

- The EKF dog show rules are enforced.
- The BC can permit the disciplined double handling.
- In case the BC is a member of its international breed organization which enforces a special rules for classes or at the dog show process, the BC is free to follow its international breed organization show rules unless EKF general dog show rules are not violated.
- National club show delegate must be presented.
- The BC might ask the EKF permission of organizing a CAC title awarding show for maximum once a year.
- The BC might organize a championship show maximum once a year.
- The BC must submit the dog show or trail results & catalog maximum one month after the show.

Titles

- The BC is addressed to grant the following titles:
 - 1- BC Champion “not less than 2 CW (class winner) during two years”.
 - 2- BC winner.
- In case the BC is a member of its international breed organization which enforces a special titles. The BC is free to enforce them too after the EKF approval.
- EKF approval is a must on any BC special titles awarding.
- The BC is free to appoint more requirements for obtaining titles.
- The BC must deliver titles to the EKF each three months.

Suspension

If the BC breaks or violates any of the up mentioned regulations or any term of the contract the EKF disciplinary committee is in charge of inspecting & investigating then proposing the appropriate sanction to the EKF GC, starting with a written warning, passing by a periodic suspension ending up with fully suspension of the BC.
